5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The cables are to be manufactured, examined and tested by ÜNIKA ÜNİVERSAL KABLO SANAYİ VE TİCARET A.Ş in accordance with the type described in this certificate and Bureau Veritas Rules for the Classification of Steel Ships.

5.2 - Arrangements shall be made for a Society's Surveyor to attend the relevant tests and examinations at manufacturer's works or to perform the relevant audits when an alternative survey scheme (BV Mode I) has been agreed. Relevant Bureau Veritas certificate will be issued after satisfactory completion of the procedure.



6. MARKING OF PRODUCT :

The cable shall be marked on the surface outer sheath, in a durable legible and visible manner, with the following information through the length of cable:

- 1) - Voltage grade.
- 2) - Cable symbol and temperature class.
- 3) - Number of conductors and conductor size.
- 4) - Applicable standard(s) to flame retardant and fire resistance if any.
- 5) - Manufacturer's name or trade mark.
- 6) - Year of manufacture.

7. OTHERS :

7.1 - This approval is given on the understanding that the Society reserves the right to require check tests to be carried out on the cables at any time and that:
